

ALCOLIN COMPETITION 2026

Terms and Conditions

Promoter

This competition is organised by Bostik South Africa (Pty) Ltd (Registration Number: 200001147507), trading as Alcolin, with registered address at 1 Beverley Close, Montague Gardens, Cape Town, 7441, South Africa ("the Promoter").

Eligibility

The competition is open to legal residents of **South Africa, Eswatini (Swaziland), Namibia, and Zimbabwe**, aged 18 years or older.

Directors, members, business partners, employees, sales agents, advertising agency staff, advisors, consultants of the Promoter and its associated companies, as well as their immediate family members, are not eligible to enter.

Competition Period

The competition will run from 1 March 2026 to 31 May 2026. Entries received after the closing date will not be considered.

How to Enter

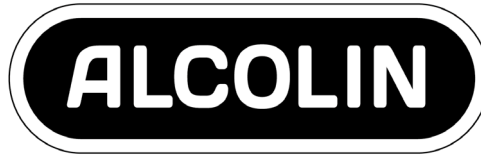
To enter the competition, participants must:

- Buy any participating Alcolin product from participating stores
- Write their full name and contact details on their till slip or official entry form
- Place the completed till slip or entry form into the designated competition entry box in-store

Only entries completed and submitted during the competition period will be eligible.

Prizes

Twenty-one (21) winners will each receive one (1) Stanley 7-Drawer Cabinet. Prizes are not transferable, not exchangeable, and may not be redeemed for cash.



Prize Allocation Across Countries

The competition will run across South Africa, Eswatini (Swaziland), Namibia, and Zimbabwe.

The twenty-one (21) prizes are pre-allocated per participating country as follows:

- South Africa: 18 prizes
- Namibia: 1 prize
- Eswatini (Swaziland): 1 prize
- Zimbabwe: 1 prize

Winners will be selected by means of a random draw conducted separately within each participating country from all valid entries received in that country during the competition period.

Winner Selection and Notification

Winners will be selected by means of a random draw conducted by the Promoter or an appointed independent party on 29 June 2026.

Winners will be notified via telephone, email address or social media within 72 hours of the draw. If a winner cannot be contacted after six (6) attempts during business hours within 72 hours, the prize will be forfeited and an alternative winner will be drawn.

Verification

Winners may be required to provide valid identification and any additional documentation reasonably requested by the Promoter to verify eligibility. Failure to provide such documentation within five (5) working days may result in forfeiture of the prize.

Prize Delivery

By entering the competition, participants consent to the use of their name, image, and/or likeness for promotional and marketing purposes related to the competition without further remuneration.

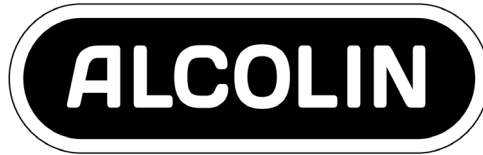
General
